GOALS OF THE WORKSHOP

- To gather diverse perspectives from Indigenous Peoples, organizations, entities and government on issues concerning meaningful engagement.
- To gain validation of the principles and lessons learned that are outlined in the MEMA report.
- To address the following issues which are not adequately addressed in the literature:
 - o Are the right people being engaged?
 - Are the current practices for monitoring and ensuring engagement considered meaningful by participants?
 - Are there accountability processes in place to ensure that meaningful engagement is undertaken by parties?

TOPICS

Measures of Successful Engagement

- Representation: Are the right people being engaged?
- Measuring successful engagement: What are the current practices for monitoring and ensuring engagement and how can they be improved?

Accountability

- What processes are in place to ensure that engagement is meaningful?
 - How are governments, industry and organizations accountable to ensure their engagement practices are meaningful?
 - How are Indigenous Peoples, communities and groups accountable for their meaningful participation in the engagement process?
- How can current processes be improved?

EXPECTED OUTCOMES

- Identifying key elements of meaningful engagement.
- Profiling case studies of engagement practices.
- Providing lessons learned to help strengthen meaningful engagement based on current practices.
