RECORD OF DECISIONS AND FOLLOW-UP ACTIONS PAME I-2017 (29 January-1 February 2017)

Copenhagen, Denmark

Opening of the Meeting

PAME thanks the Kingdom of Denmark for hosting this Meeting and notes with appreciation the welcoming remarks from Hanne Fugl Eskjær, Senior Arctic Official of Kingdom of Denmark and Lida Skifte Lennert, Head of Representation from Greenland.

Information from the Chair and Secretariat (Agenda Item 3)

PAME took note of following issues as summarized by the PAME Chair, Renée Sauvé:

- Outcomes from relevant Arctic Council meetings including the SAO meeting 4-6 October 2016;
- the active communications and meetings of the Arctic Council SAO Chair with working groups chairs and secretaries;
- the Task Force on Arctic Marine Cooperation (TFAMC);
- o the new common operating guidelines for the Arctic Council working group;
- o the 13th meeting of the Conference of the Parties to the Convention on Biological Diversity in Cancun, Mexico, 4 17 December 2016; and
- o the Arctic Frontiers Conference 23-27 January where the PAME Chair presented within both the policy and science sections of the Conference.

PAME notes with appreciation the presentation by WWF on the Arctic Council Conservation Scorecard methodology which aims to assist the Arctic Council with reporting and strategic planning.

PAME notes with appreciation the summary of Finland's 2017-2019 Chairmanship Program which will be presented at the upcoming SAO meeting 8-9 March 2017.

Framework for a Pan-Arctic Network of Marine Protected Areas (MPAs)

PAME approves the CAFF-PAME Protected Areas Indicator Report.

PAME appreciates the update by the USA on the "Desktop study on area-based conservation measures and its linkages to categories of Arctic marine biodiversity 'Toolbox'" project and recommends the following timeline:

 February 8: PAME members have been asked to submit comments on the 2nd draft (January 26 version) of the PAME MPA-network Toolbox: Area-based Conservation Measures and Ecological Connectivity ("Toolbox Report").

- <u>February 15:</u> Deadline for project leads to add key results, as needed, from February Workshop and address PAME member comments to produce a 3rd draft of the Toolbox Report. Send to SAOs and PAME members.
- <u>February 28:</u> Deadline for PAME members to submit any final critical comments (e.g. comments limited to the text changes made to latest version) to PAME leads.
- o <u>March 8-9:</u> PAME Chair presents Toolbox Report to SAOs for approval, noting if there are any outstanding issues (per the Feb 28 receipt of comments).
- o <u>March 31</u>: Deadline for project leads to resolve any outstanding issues for Ministerial approval of the Toolbox Report.

PAME thanks Sweden and Finland for their workshop proposal and supports the 3rd Arctic MPA workshop, scheduled for 21-22 September 2017 in Helsinki, Finland back-to-back with PAME II-2017.

<u>By March 31</u>, PAME requests recommendations of experts (including government, indigenous peoples, academia, international organizations, and others) for participation in the 3rd Arctic MPA workshop. Workshop co-leads will send out a letter of invite with further information and expertise required in line with the workshop proposal.

PAME approves the MPA Network Toolbox Project work plan for inclusion into the PAME 2017-2019 Work Plan, which includes the 4th Arctic MPA workshop in 2018, to potentially be hosted by Canada, to convene MPA managers, Indigenous peoples, community representatives, and other MPA partners to share experiences in planning and developing Arctic MPA networks.

PAME requests the PAME Secretariat to liaise with the CAFF Secretariat to convey the status of, and invite the cooperation of CAFF, in the MPA Expert Group's 2017-2019 activities. PAME Heads of Delegations are also encouraged to reach out to their respective CAFF Heads of Delegations.

Arctic Marine Shipping Assessment (Agenda Item 5)

AMSA I(A) – Linking with International Organizations

- ✓ PAME thanks Dr. Jürgen Holfort of the Federal Maritime and Hydrographic Agency of Germany for his presentation on behalf of the WMO-IOC Joint Technical Commission for Oceanography and Marine Meteorology (JCOMM) Expert Team on Sea Ice (ETSI) on ETSI's Arctic-related activities.
- ✓ PAME thanks Søren Enemark of the Danish Shipowners' Association for his presentation, including on their priorities with respect to Arctic shipping operations.
- ✓ PAME thanks Jens Peter Holst-Andersen of the Danish Ministry of Defence for his presentation on the assessment report regarding "Marine Environmental Risk—Concerning Waters In And Adjacent To Greenland And The Arctic."
- ✓ PAME thanks Mads Bentzen Billesø of the Danish Maritime Authority for his presentation on ArcticWeb to the Shipping Expert Group.
- ✓ PAME approves the Terms of Reference for the Arctic Shipping Best Practices Information Forum, requests the Shipping Expert Group Co-Chairs to work with Finland as the incoming Chair of the Arctic Council and the PAME Secretariat to develop an agenda for and issue invitations to the Forum's first meeting -- tentatively scheduled for

5-6 June 2017 in London -- and invites the Forum to submit a report to PAME II-2017 regarding that meeting.

AMSA I(B) – IMO Measures for Arctic Shipping

- ✓ PAME decides to include in its 2017-2019 Work Plan the four projects in connection with mitigating risks associated with the use and carriage of HFO by vessels in the Arctic (Annex I);
- ✓ PAME welcomes the project proposal regarding PAME's role in harmonized implementation of the Polar Code submitted by Finland and the Russian Federation to PAME I-2017, and invites them intersessionally to revise the project proposal for circulation by 30th of April 2017, taking into account comments received during the Shipping Expert Group (SEG) meeting, including with respect to timing and the role played by the Paris and Tokyo Port State Control MOUs. Comments on the revised project proposal are requested by 31st of May 2017 with the view to finalizing the revised proposal at PAME II-2017.
- ✓ PAME encourages Arctic States that are members of either the Paris MOU or the Tokyo Port State Control MOU to support action by those organizations to initiate a joint concentrated inspection campaign on the Polar Code.
- ✓ PAME invites the USA to submit to PAME II-2017 an information paper describing the structure, composition and role of the Paris and Tokyo Port State Control MOUs.

AMSA I(C): Uniformity of Arctic Shipping Governance

✓ PAME invites Canada to make a presentation at PAME II-2017 regarding the concept of safe and low impact shipping corridors.

AMSA I(D) – Strengthening Passenger Ship Safety

✓ PAME requests the Secretariat to invite a representative of EYOS Expeditions to make a presentation at PAME II-2017 on safe and environmentally sound navigation in the Arctic of non-commercial yachts and pleasure craft and to identify areas of potential collaboration with PAME on such issues.

AMSA II(A) – Survey of Arctic Indigenous Marine Use

✓ PAME welcomes an update at PAME II-2017 by the Aleut International Association on its Arctic Indigenous Marine Use: Tools For Communities Project.

AMSA II(D) – Specially Designated Arctic Marine Areas

✓ PAME approves the Regional Reception Facilities Project (RRFP) "Arctic Regional Reception Facilities Plan Outline and Planning Aid" and associated "Draft Working Paper" submitted to PAME I-2017 and requests Arctic States to forward these documents to their respective IMO delegations for consideration and further action as appropriate. The RRFP expert group will inform the Shipping Expert Group on relevant developments.

AMSA II(E) – Protection from Invasive Species

✓ PAME approves a revised text for the shipping related priority action items in the Arctic Invasive Alien Species Strategy and Action Plan (ARIAS) and decides to the following timeline to finalize the ARIAS for submission through the CAFF Working Group to SAOs and Ministers for approval:

- o <u>Feb 10:</u> Revised version with outstanding comments sent to PAME and CAFF and HoDs for review and note sent to the Chair of SAOs informing him about the process and seeking guidance, if needed.
- o <u>Feb 11-28</u>: Teleconference amongst the PAME and CAFF HoDs to resolve edits to the remainder of the ARIAS.
- <u>Feb 28</u>: Final agreed upon draft circulated to States and PPs for final approval (1 week)
- o <u>March 8:</u> ARIAS circulated to SAOs for approval at the April SAO Executive meeting (tentative: 4-6 April)
- o April-May: preparation for release of document e.g. layout and printing

AMSA II(G) – Addressing Impacts on Marine Mammals

✓ PAME invites WWF to submit an information paper to PAME II-2017 summarizing research on underwater noise and its effect on Arctic marine biodiversity.

AMSA II(H) - Reducing Air Emissions

✓ PAME invites Norway to submit a brief update on IMO's work with respect to black carbon, specifically the outcome of the 71st Session of the IMO's Marine Environmental Protection Committee (3-7 July 2017) to the Shipping Expert Group at PAME II-2017, if relevant.

AMSA III(B) – Arctic Marine Traffic Systems

- ✓ PAME welcomes finalization of the Arctic Shipping Traffic Data (ASTD) project documents and, subject to final national review, approves the:
 - MOU Among the Arctic States Regarding Arctic Ship Traffic Data Sharing;
 - o MOU Attachment 1: Form for a Standard Agreement on Access to and use of ASTD Data: and
 - o MOU Attachment 2: Sample of a Data Sharing Agreement.
- ✓ PAME thanks those Arctic States which have committed to making financial contributions as outlined in MOU Attachment 3 (Network Costs Estimated Pro Rata Shares) to carry out the ASTD project and invites all other Arctic States to make a similar commitment and to notify the PAME Secretariat as soon as practicable. PAME also welcomes financial contributions from Observers.
- ✓ PAME requests each Arctic State to notify the PAME Secretariat as soon as practicable of its ASTD project point of contact for listing in MOU Attachment 4: Designated Contact Persons.
- ✓ PAME requests the PAME Chair to forward the ASTD project documents to the SAOs, and invites, subject to final national approval, SAOs to approve and sign the ASTD MOU at the 8-9 March 2017 SAO Meeting.

Other items

✓ PAME approves the AMSA Implementation Progress Report (2015-2017) subject to final review and requests that the co-leads Finland, Norway and Iceland circulate electronically a final version reflecting all comments received by 8 February for approval by HoDs prior to its submission as a PAME deliverable to the SAOs.

- ✓ PAME thanks the representative from Italy, Dr. Luca Fiorani, for his presentation on Italy's Arctic work and interests, in particular with respect to shipping activities.
- ✓ PAME thanks Dr. Jong Deog Kim of the Republic of Korea for the invitation it extended to PAME shipping experts to attend Korea's "2nd Arctic Partnership Week" in Korea (early December 2017) to discuss projects and issues on PAME's shipping agenda and explore increased collaboration with Arctic Council Observers on shipping related matters.
- ✓ PAME requests the Secretariat to extend an invitation to a representative of the International Council on Clean Transportation (ICCT) to make a presentation at PAME II-2017 relating to the use and carriage of HFO by ships in the Arctic as it pertains to the HFO projects in PAME's 2017-2019 Work Plan.
- ✓ PAME requests the Secretariat to extend an invitation to the Finnish Maritime Environment Tri-authority Operations (METO) to make a presentation at PAME II-2017 regarding the Finnish METO maritime cooperation on the maritime surveillance systems, communication means and risk analyses methods to produce a common maritime situational awareness in a cost effective way.
- ✓ PAME requests the Secretariat to invite a representative from the Finnish Shipowners' Association to make a presentation at PAME II-2017 on Arctic shipping.
- ✓ PAME requests the Secretariat to invite a representative of an Arctic Council Observer State (e.g., Germany) to submit a paper to PAME II-2017 and make a presentation at that meeting on its Arctic shipping interests and activities.
- ✓ PAME welcomes ongoing attendance at its semi-annual meetings by an EPPR representative, including participating in PAME's Shipping Expert Group.
- ✓ PAME approves the Arctic Marine Shipping work plan items for inclusion into the PAME 2017-2019 Work Plan (Annex I).

Arctic Offshore Resource Exploration and Development (Agenda item 6)

- ✓ PAME approves the Resource and Exploration and Development Expert Group (REDEG) Terms of Reference (ToR) and scope of work.
- ✓ PAME decides to focus future presentations and information gathering on offshore renewable energy, noise from activities, mining activities that can affect the marine environment and non-emergency offshore oil and gas activities.
- ✓ PAME thanks OSPAR representative, Charlotte Mogensen for her comprehensive presentation on OSPARs' Offshore Industry Committee and Environmental Impacts of Human Activities Committee work. PAME noted the synergies between OSPAR and PAME REDEG on issues concerning offshore oil and gas, offshore renewable energy, and marine noise, and encourages the exploration of possible future cooperation, as appropriate.
- ✓ PAME thanks the REDEG members for the draft Meaningful Engagement of Indigenous Peoples and Communities in Marine Activities (MEMA) Part I Report and requestes that REDEG distribute the Introduction section of the MEMA Part I Report to PAME members by February 7. Deadline for comments on all of the MEMA Part I Report is February 9, in time to submit a final MEMA Part I Report to the March 2017 SAO Meeting.
- ✓ PAME welcomes the final MEMA Workshop Report.

- ✓ PAME appreciates the work by Canada and the Secretariat for the addition of over 200 new entries in the MEMA Online information database.
- ✓ PAME approves the revised MEMA Part II work plan items for inclusion into the PAME 2017-2019 Work Plan.
- ✓ *PAME notes with appreciation the work done by the REDEG members on:*
 - The online survey on implementing recommendations of the System Safety
 Management and Safety Culture Report that EPPR has agreed to distribute to national
 regulators.
 - The survey related to possible updates of the Arctic Offshore Oil and Gas Guidelines (AOOGG 2009) and notes REDEG's decision not to pursue new 2017-2019 projects.

Ecosystem Approach to Management (Agenda item 7)

- ✓ PAME welcomes the 2015 2017 Progress Report of the Joint Ecosystem Approach Expert Group (EA-EG) and acknowledges the substantial accomplishments documented in the report.
- ✓ PAME welcomes the Summary Report of the International Science and Policy Conference on the Status of Implementation of the Ecosystem Approach in the Arctic, subject to final edits and comments received by February 8.
- ✓ PAME approves the report, Status of Implementation of the Ecosystem Approach to Management in the Arctic, subject to final edits and comments received by February 8.
- ✓ PAME appreciates the progress made by the expert group in advancing understanding of integrated ecosystem assessment, IEA, through its participation in the formation of, and participation in, the ICES Working Group on Integrated Ecosystem Assessment in the Central Arctic Ocean, WGICA, and participation in the meetings of scientific experts on fish stocks in the central Arctic Ocean, FiSCAO.
- ✓ PAME approves to the EA-EG work plan items for inclusion into the PAME 2017-2019 Work Plan (Annex I).

- ✓ PAME agrees to submit the current draft (version 26 January) on "Achievements 2015-2017" for SAO Report to Ministers by 10 February.
- ✓ PAME requests its Secretariat to revise the PAME Work Plan 2017-2019 (short and long version) based on discussions at this Meeting (Annex I) and send to PAME Members for their review by **February 10** with deadline for comments by **February 24**. The PAME

- Secretariat will submit a revised draft version to the Arctic Council by **February 27** deadline.
- ✓ PAME secretariat to send to PAME Members the **March 24** AC Chairmanship version of the SAO Report to Ministers(PAME sections on Achievements and 2017-2019 Work Plan) with **April 7** for final review and agreement by PAME Members.
- ✓ PAME agrees to include the following projects in the PAME 2017-2019 Work Plan:
 - Revised version of the Marine Litter in the Arctic Project (Phased Approach) subject final comments. Confirmed co-leads are: Sweden, Norway, Iceland and AIA and note interest by Finland, Canada, USA, Kingdom of Denmark and Germany. Co-leads are requested to send to PAME Members a revised version of this Project based on discussions and inputs from this meeting by February 10 with comments due February 24 for inclusion into the PAME 2017-2019 Work Plan for submission to the Arctic Council by the February 27 deadline.
 - O Good Practice Recommendations for Environmental Impact Assessment, EIA, and Public Participation in EIA in the Arctic (Arctic EIA) Project. PAME notes that this project is subject to approval by SDWG. PAME will include this Project in the 2017-2019 Work Plan and contribute to this work based on its project plan and relevance to PAME's work.
- ✓ PAME agreed to the following process/timeline to finalize the 1st AMSP Implementation Report for submission to SAOs and Ministers for information.
 - o <u>Feb 10:</u> Revised draft version submitted to SAOs for information, noting that additional information from EPPR and ACAP to be included.
 - o <u>March-April:</u> Revised based on comments to include links to reports/activities (as relevant) and circulate final draft to PAME, including proposed layout.
 - o April-May: preparation for release of the document i.e. final layout and printing.
- ✓ List of PAME deliverables to the 2017 Ministerial is in Annex II.
