Background:

The Arctic Council's Arctic Marine Strategic Plan 2015-2025 (AMSP) provides a framework to guide its actions to protect Arctic marine and coastal ecosystems and to promote sustainable development.

PAME has produced two AMSP Implementation Reports in close collaboration with other Arctic Council Working groups.

The 2nd AMSP Implementation Report (2017-2019)

The PAME Secretariat produced the 2nd AMSP implementation report for the 2017-2019 period is here, including the link to the implementation matrix. Each Working Group provided status on the implementation of the AMSP strategic actions as relevant to their respective work plan activities. The AMSP Implementation Plan provides a mechanism to systematically track progress and status of its 40 Strategic Actions. The 2nd report was developed in close collaboration with other Arctic Council WGs to ensure transparent and systematic cross-working group progress, provide a status reporting mechanism for all work plans, as relevant, and contribute to collaboration on cross-cutting marine-related issues.
